**Skills and Training Fee** - The Suburban Football Club (SFC) is committed to offering high performance soccer programs. Based on the Canadian Soccer Association Long Term Player Development Model, SFC will be providing all youth players with expanded training opportunities. SFC will offer a 4:1 training to game ratio, 2 training session per week with Club trainers, two per week with top-notch, Provincial B licensed coaching staff. In order to provide this level of competitive training each player (excluding Senior A) will be required to pay a **skill and turf fee of \$200** in addition to the registration fee.

**There will be a \$25 non-refundable tryout fee due at the first tryout.**
