## Article 15 Board of Director Meetings:

15.6 The Club Manager shall be a non-voting member of the Board of Directors.

15.8 The Board of Directors shall be vested with the authority to direct the affairs of the Club.

Note: Role of Board is specified at Article 4.2.
15.9 Contracts, documents or any instruments in writing requiring the signature of the Club, and of value in excess of $\$ 10,000$ shall be signed by the Financial Officer one executive member (President, Vice-President or Secretary) and one other Director of the Board. Any contracts with a value equal to or less than $\$ 10,000$ will be processed as per Article 14. All contracts, documents and instruments in writing so signed shall be binding upon the Club. Board of Director Approval is required for all binding instruments in excess of \$10,000.
Note: In general entry is not relevant specifically to Director Meetings. More importantly such details are included in the Finance and Procurement policies.
15.10 The Board of Directors shall approve an annual budget.

Note: this function is covered under Governing of the Club (Articles 2 and 4.2).
